





Resolution of the managing director of the Health Research Institute of the Balearic Islands Foundation calling for a selection process for the hiring of a postdoctoral researcher for the FOLIUM program of the project "GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa", a call financed by the 2023 annual plan of the Sustainable Tourism Tax (ITS2023-121 GREAT) for the research line "Nanotechnology-based sensors for the detection of diagnostic biomarkers of infection".

## File code: FOLIUM-2023-GTERi

Decree 68/2012, of 27 July, regulating the *Official Gazette of the Balearic Islands* (BOIB), establishes in article 15 the competence to order the insertion of edicts in the BOIB and, in point 4, specifies that public institutions or entities not mentioned in the first three points must accredit the bodies and persons who, in accordance with their specific regulations, are empowered to order or request the insertion of texts in the BOIB. If there is no specific accreditation, it must be understood that it corresponds to whoever exercises the representation of the body, entity or institution from which the text emanates.

Furthermore, in accordance with article 27 of the Foundation's Statutes, the managing director of the Foundation is the person competent to develop the personnel policy approved by the Board of Trustees and, for this purpose, select staff, sign or terminate contracts, execute the agreements of the Board of Trustees in matters of remuneration, agree on sanctions, exercise senior management of the personnel serving the Foundation and maintain relations with the staff representation bodies, in addition to all those actions that are entrusted to him in this matter, without prejudice to the functions that correspond to the president.

For all these reasons, I dictate the following:

## Resolution

Order the insertion in the *Official Gazette of the Balearic Islands* of the call for the hiring of a postdoctoral researcher for the FOLIUM program from the project "GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa" (see attached annex).

ANNEX 1

Call for the recruitment of a postdoctoral researcher for the FOLIUM program of the project "GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa", call funded by the 2023 annual plan of the Sustainable Tourism Tax (ITS2023-121 GREAT)

The Foundation is entrusted with, among others, the function of managing means and resources for the execution of clinical, basic and applied research programs, technological development and innovation in the field of health.

In order to carry out these functions, the Foundation needs to incorporate a postdoctoral researcher for the FOLIUM program of the project "GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa", a call financed by the 2023 annual plan of the Sustainable Tourism Tax (ITS2023-121 GREAT).

The aim of the project "GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa" is to establish programmes to attract research talent that will promote the recruitment of research and research support staff at the IdISBa Health Research Institute Foundation (IdISBa), on a competitive basis, who can contribute to investment, research and innovation in the production of health results at the IdISBa Foundation.

Article 23.2 of Law 7/2010, of July 21, on the instrumental public sector of the Autonomous Community of the Balearic Islands, establishes the criteria to be followed by public entities of the Administration of the Autonomous Community when hiring labor personnel.

Articles 17 and 18 of Law 3/2007, of March 27, on the civil service of the Autonomous Community of the Balearic Islands, provide that the principles of equality, merit, capacity and publicity must be applied in hiring.

Decree 17/2019, of March 15, approving the Statute of research staff at the service of health research institutes of the Balearic Islands, establishes the legal regime of research staff at health research institutes of the Balearic Islands integrated into the instrumental public sector of the Autonomous Community.

The introduction of an open-ended contract for scientific and technical activities by means of Royal Decree Law 8/2022, of April 5, validated by Law 17/2022, of September 5, reforming the science law, has among its objectives to improve the job stability of research, technical or research project management personnel and is the modality that we propose for the hiring of personnel who are awarded this call.

Although article 20.1 of the science law expressly includes a general reference for all types of employment contracts for research staff, which includes the scientific-technical activities contract –ET and its development regulations, applicable collective agreements, and where appropriate the EBEP–, we must consider that the specific regulation that must be applied is article 23 bis, and the other referenced regulations will act as a supplementary regulation applicable in each case. To this end, IdISBa proposes that the successful bidder's research staff enter into a scientific-technical activities contract as regulated by Article 23 bis of the Science Act, the purpose of which is "the carrying out of activities linked to lines of research or scientific-technical services, including the scientific-technical management of these lines,







which are defined as a set of knowledge, concerns, products and projects constructed in a systematic manner around a thematic axis where activities carried out by one or more research groups converge, and which will require their development following the appropriate methodological guidelines in the form of R&D&I projects."

Section two B of the Agreement of the Governing Council of 23 February 2007, modifying the scope of application and determining the scope of control of point 5 of the Agreement of the Governing Council of 19 December 1995, provides for the accounting and accountability of public companies of the Autonomous Community, with regard to the selection of staff of public entities of the Autonomous Community.

For all these reasons, and in the exercise of the powers attributed to me by article 28.1 and the current founding statutes,

# I CALL:

The process for recruiting a postdoctoral researcher for the FOLIUM program from the project «GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa», for the research line «Nanotechnology-based sensors for the detection of diagnostic biomarkers of infection» of the Health Research Institute of the Balearic Islands Foundation with the following requirements, characteristics and selection criteria:

## I. Requirements for the position

## Requirements of the candidate

- Having obtained a doctorate in the field of Biomedicine, Biotechnology or Bioengineering as of January 1, 2019<sup>1</sup>.
- Have Spanish nationality, or another nationality in cases where article 57 of the TREBEP allows access to public employment.
- Possess the functional capacity to perform tasks.
- Be sixteen years of age or older and not exceed the maximum mandatory retirement age.
- Not having been dismissed through a disciplinary procedure from the service of any of the public administrations or the constitutional or statutory bodies of the autonomous communities, nor being absolutely or specially disqualified from public posts or positions through a court ruling. In the case of being a citizen of another state, not being disqualified or in an equivalent situation, nor having received any disciplinary or equivalent sanction that prevents him/her from accessing public employment in his/her state and under the same terms.

- Complete the self-assessment form (annex 3).

CVs from people who do not meet the requirements will not be considered.

Failure to comply with any of the rules described above will result in the candidate being excluded from the selection process.

# II. Functions

- Develop research programs specific to their area, joining the IdISBa research group.
- Strengthen existing lines of research.
- Produce and promote publications of national and international impact.
- Obtain competitive projects.
- Generate and transfer knowledge with an impact on health to the health system and the population.
- Synthesis, characterization, modification and integration of nanomaterials in diagnostic sensors.
- Validation of new infection biomarkers based on pathogen phenotype and/or host response.
- Study of the interaction between nanomaterials and leukocyte cells for their integration into diagnostic sensors.

## III. Submission of applications

Applications can be submitted at the physical registry of the Balearic Islands Health Research Institute Foundation or by email<sup>2</sup> to the Resources Unit Human resources: <u>idisba.convocatorias@ssib.es</u>. The file code "FOLIUM-2023-GTERi" must be indicated in the subject of the email. Applications submitted by any other means, mail or format will not be considered submitted.

The deadline for receiving applications will be **15 working days** from the day following the date of publication of the call.

Applicants must submit, along with their application, the documentation proving the requirements and merits they claim in the manner established in these rules. No merit may be assessed that has not been accredited by providing the corresponding documentation within the application submission period.

## IV. Admission of applicants

Once the deadline for submitting applications and documentation regarding the requirements to participate in the selection process has ended, a resolution will be published on the Foundation's website approving the provisional list of admitted and excluded applicants, indicating the reasons for exclusion.

Exclusion cases: application submitted after the deadline; failure to meet the requirements.

Excluded or omitted applicants will have a period of **3 working days**, starting from the day after the provisional resolution is published, to correct the defects or attach the required documentation. If they do not correct or attach the required documentation, it will be understood that they have withdrawn their application.

Once the period indicated in the previous paragraph has ended, a resolution will be issued approving the final list of people admitted and excluded from the selection process, together with the provisional scoring system. Applicants will have a period of **3 working days**, starting on the day following the publication of the final list of those admitted, to correct any scoring defects or attach the required documentation. Information previously published (whether it has been previously corrected or not) cannot be corrected if there have been no changes or corrections by the qualifying court.

After publication, all candidates who have submitted their application will be assigned an individual date and time for the interview. The candidate must confirm their participation in the interview in order to be assigned a specific time slot. If the interview is conducted virtually, the original documentation must be submitted when requested by the IdISBa Human Resources Unit.

#### V. Reservation in favor of persons with disabilities

There is a 7% reserved place for people with disabilities at IdISBa, in accordance with Royal Legislative Decree 5/2015, of 30 October, approving the Revised Text of the EBEP Law. However, this place is not reserved for this purpose.

#### VI. Type of contract

Permanent contract in accordance with article 23 bis of the Science Law, in the program "GREAT IdISBa: Generate Research Excellence and Advanced Therapies in IdISBa"

The contracts financed with the grants covered by this call follow the compatibility rules in force at IdISBa.

**Remuneration**: 35 164,42 euros gross per year in 12 installments.

Each contract will have a maximum grant of €2 000 for mobility activities, understood as stays of at least three months in national or international research centres of recognised prestige.

#### VII. Accreditation of requirements and merits

The requirements and merits claimed by the applicants must be accredited with reference to the date of the end of the application period by submitting a copy or certified copy of the following documentation.

# Accreditation of merits

- **Submission of a CVA (1 January 2019 until the closing date of this call)** <sup>3</sup>. It must be submitted in electronic PDF format, generated in one of the following ways: *i)* automatically from the CVN editor or *ii)* from any institution certified in the FECYT standardized *curriculum vitae* (CVN) that offers the CVA service. At a minimum, the requirements and indicators required in the call must appear:
  - Indication of the 10 selected publications, including order as signatory.
  - Participation as IP or in the research project team, call, funding entity and type of participation.
  - Participation in conferences or other scientific meetings and type of participation.
- Publications: full copy of the selected publications (maximum 10) and completed Annex 3 indicating the position as signatory and the indexation of the journal according to the JCR of the year of publication of the article (or the latest available JCR classification in the case of publications from 2024).
- **Certificates of participation in research projects**, signed by the management of the center that manages them or an official document justifying it.
- Certificate or employment contract from the scientific institution receiving the postdoctoral stays. Professional experience: by means of a certificate signed by the person responsible for the entity where the services have been provided, specifying the length of experience in the areas assessed in this call. If this is not possible, the contract must be submitted together with the employment record.
- **Copy of certificates or diplomas accrediting** awards, mentions and distinctions, participation in patents, dissemination activities, etc.
- **Oral and written language skills:** by means of a copy of one of the following certificates:
  - a. **Catalan:** certificate issued by an official body.
  - b. English:
    - Official School of Languages.
    - Cambridge English Qualifications .
    - Linguaskill.
    - IELTS.

Applicants must submit all documents proving their merits ordered according to the sections of the merit scale and numbered consecutively (together with the self-assessment according to the template that appears in Annex 4 accompanying these bases). Merits that have not been duly referenced in Annex 4 will be assessed.

Documentation proving all merits must be submitted with the application. If unverified copies are initially submitted, the original documentation proving all merits must be presented at the interview.

    - Principal authorship: as first signatory, last signatory or responsible for correspondence in the field of biomedical research (6 points)
    - Non-principal authorship: as a signatory in another order in the field of immunology or sensors with biomedical applications (4 points)
    - Non-principal authorship: as a signatory in another order in the field of biomedical research (3 points)
  - Publications in the first quartile of the JCR:
    - Principal authorship: as first signatory, last signatory or person responsible for correspondence in the field of immunology or sensors with biomedical applications. (5 points)
    - Principal authorship: as first signatory, last signatory or responsible for correspondence in the field of biomedical research (3 points)
    - Non-principal authorship: as a signatory in another order in the field of immunology or sensors with biomedical applications (2 points)
    - Non-principal authorship: as a signatory in another order in the field of biomedical research (1 point)
- For each publication indexed in the JCR other than the previous point, reviews, books and book chapters, protocols, guides or technical reports with ISBN or ISSN:
  - As the first or last signatory or person responsible for correspondence in the field of immunology or sensors with biomedical applications (1.5 points)
  - As the first or last signer or person responsible for correspondence in the field of biomedical research (1 point)
  - As a signatory in another field in the field of immunology or sensors with biomedical applications (0.75 points)
  - As a signatory in another order in the field of biomedical research (0.5 points)







- Research projects funded in regional, national or international competitive calls in the research field referred to in the call:
  - As IP. (1.25 points for a regional project, 2.5 points for a national project and 5 points for an international project)
  - As a collaborating researcher. (0.25 points for a regional project, 0.5 points for a national project and 1 point for an international project)

# • Research mobility (25 points max.)

Postdoctoral stays in research institutions other than the centre where the doctorate was obtained. In the case of national mobility in Spain, this must involve not only a change of centre but also mobility between different autonomous communities.

- Short stays or postdoctoral work contracts of 3-6 months in the case of international mobility or 6-12 months for national mobility. (6 points)
- Significant stays or postdoctoral work contracts of 6-12 months in the case of international mobility or more than 1 year in the case of national mobility. (12 points)
- Excellent stays abroad or postdoctoral work contracts of more than 1 year that involve international mobility. (25 points)

In the event that the doctoral thesis was completed at a centre outside the national territory, if the postdoctoral activity is carried out at a centre other than that of the thesis, and always assuming the transfer to at least one other city, it is considered as national mobility based on scoring criteria, always under evaluation by scientific direction.

## • Other merits (20 points max.)

- Extraordinary award for a doctorate, diploma, bachelor's degree, master's degree or doctorate. (5 points per award)
- Participation in patents, intellectual property and creation of applicable tools ( *software*, algorithms, apps, etc.). (5 points for participation)
- PhD with international mention or completed at a foreign center (5 points)
- Outreach activities organised by scientific institutions. (0.5 points per participation; 2.5 points max.)
- Participation in conferences or other scientific meetings, through communication, presentation or poster as first or second author or speaker. (0.2 points per participation; 4 points max.)

# • Language skills (5 points max.)

- Catalan certificate:
  - Level B2. (1.5 points)
  - Level C1 or higher. (3 points)
- English Certificate:
  - Level B2. (2.5 points)
  - Level C1 or higher. (5 points)

## Personal interview (10 points max.)







In a personal interview, the candidate's suitability, based on his/her training and previous experience, for the project and research group to which his/her proposal is assigned will be assessed.

# X. Tie of candidacies

In the event of a tie, the application with the highest score will prevail, following the order of the sections of the call.

# XI. Resolution of the call

Once the personal interview process has been completed, the selection committee will draw up a final report on the selection process, which will include the list of selected candidates, who will be those with the highest score based on the results of the assessment of the accredited merits and the personal interview. After this process, a provisional resolution of the call will be published on the Foundation's website, approving the provisional list of the selection process.

Applicants will have a period **of 3 working days**, starting from the day after the publication of the provisional list for corrections. After this period, the final resolution of the call will be published. The entity will contact the selected persons to inform them of the resolution of the selection process. In the event of the applicant's resignation, the order of scores obtained by the rest of the applicants will be followed.

#### XII. Other provisions

- 1. On an annual basis, beneficiaries must submit by email to the address <u>idisba.gestioncientifica@ssib.es</u>, a report of the activities carried out following **Annex 4** of the call, in which they must record the most notable aspects of the development of their work, with the approval and signature of the person responsible for the group.
- 2. In the works published as a result of the activity carried out, the financing by the 2023 annual plan of the Sustainable Tourism Tax and the management of the scholarship by the IdISBa will be stated.
- 3. The results arising from the funded project must be published in open access.
- 4. In all matters not specified in this call, the instructions provided by the Scientific Directorate of IdISBa will be followed, which will resolve the incidents generated by this call.

#### XIII. Resources

The social jurisdiction is competent to resolve disputes arising from these bases, in accordance with Law 36/2011, of October 10, regulating social jurisdiction, without any other appeal being filed through administrative channels or any claim prior to the social judicial channel.
